#### 1. Discussion

The financial statements reflect that the Association funds are in good hands, showing a healthy surplus and strong balance sheet.

CEO Andrew Rowe provided a snapshot of some of the statistics of the Association managing tenancies across a number of programs. Andrew provided information relating to key activities undertaken during the year, including the focus of protecting tenants from Covid. The Association's response has been well considered and thorough and Andrew appreciated the cooperation, input and support from the relevant Government agencies. The employees undertook a number of formal training sessions, improving organisational strength during the year. Financially the Association is doing well and we have some reserves we plan to devote to increasing housing, when the right opportunities arise. Andrew encourages stakeholders and members to read the Annual report.
